Presidents report 2014-15:

Upgrades to the ovals at St Bernard's College over the summer created havoc amongst the sporting clubs associated with the college and will continue to do so for the foreseeable future. Much of our training was moved to Keilor Park where in general there was good co-operation with other users of the facility.

There was one exception, it appears that one member of the Keilor Little Athletics organisation considered that hammer throwing was damaging the facilities (throwing cage nets and concrete track edging).

I concede that hammer throwing is a dangerous pastime especially to other users of the facility. Because of this we had arranged the the hammer would only be thrown when the club were the sole users of the track. However it appears that without the knowledge of the Keilor Little Athletics committee the Brimbank City Council were approached by someone from Little Athletics, they in turn approached Athletics Victoria on a very technical basis for a ruling about throwing the hammer at Keilor Park. The response was that the throwing cages at Keilor park are not suitable for hammer throwing. The council then banned hammer throwing at the facility.

An examination of the reported damage to the nets around the throwing rings does not indicate that hammers were a problem, the construction of the net supports, strong winds, and the occasional bit of vandalism are more likely causes. Damage to the concrete edging would appear to be caused by athletes walking back to the ring while dragging a hammer or athletes rolling a 2KG discus back into the ring.

So we are in a position that our hammer throwers may train at Keilor Park but can not throw the hammer. The provision of a IAAF standard hammer throwing facility at Keilor Park is an expensive business which is currently being researched.

Athletics Victoria changed the summer program by reducing the number of "Shield' rounds (with the majority before Christmas), introducing a "Shield" zone on zone competition which required travel to remote venues and introducing a "Knockout" competition for a limited number of athletes.

The committee supported efforts by other clubs in the western suburbs to get Athletics Victoria to increase the number of "Shield" rounds after Christmas. The club members attendance at the remote zone on zone competitions was excellent and the club was a major contributor to the success of the "Yellow Zone" (generally western and north western suburbs) in the zone versus zone final.

The "knock out" competition was poorly supported by athletes across the board, however our club supported the operation of these competitions and our athletes who participated.

Technology and the way things are done marches on and over the year the treasurer has driven the process of moving some of our accounts from the NAB to the Westpac bank. There have been changes to how we access our accounts with the implementation of a "debit" card (with a \$ limit) which obviates the need for cheques with two signatures. Thank you David.

This year we had David de Vries on the committee in the role of "communications" person. David has taken on the generation of club email bulletins, the management of the website and the clubs presence in "facebook" and who knows what else. Thank you David.

Operating at St Bernard's College and Keilor Park over the summer has meant more work for our coaches. Thank you all for your efforts.

Where are we?

My wife and I occasionally look at each other and say "where did 50 years go". I can ask the same questions about the club "where did 50 years go, what happened?"

A long time ago the club was instrumental in the creation of Keilor Little Athletics and the Keilor Heights women's athletics club. With the the merger of the men's and women's athletic organisations we merged with Keilor Heights, possibly the most significant event in the clubs history.

There has been a lot put into coaching and competition. Members have come and gone over the years, but I am sure that the club has contributed to the lives of most members. We provide a happy, sociable environment where anyone of any ability can find coaching, support, a friendly ear and friendship. Members may not have been champion athletes but I am sure they learned some skills, the value of personal effort, the importance of team work and how to get on with people.

So, 50 years. Where do we go from here? Another 50 years may be a challenge for some of us.....

In the shorter term there is issues around how we support members in the more esoteric (and expensive) disciplines such as hammer throwing and pole vaulting.

There is an ongoing requirement for coaches. We need people with the interest, skills and ability and the time. Coaching appears to be moving from "amateur club based" coaches to professional coaches who charge for their services. Somehow we must manage things so that we have good coaches but at reasonable costs to the club and its members.

I believe we must continue to develop our relationship with Keilor Little Athletics our co-tenant at Keilor Park and the Brimbank City council the owners of the park. A good relationship with Little Athletics will provide a path for youngsters and help them continue in athletics and and hopefully contribute to the clubs membership.

Currently the Brimbank council currently provides access to the park on a simple semi-annual pay as you go basis with the council bearing responsibility for maintenance and enhancements to the facilities. To ensure that the facilities for disciplines like hammer, pole vault, hurdles, steeple chasing become available we must be pro-active with the council, Little Athletics and possibly Athletics Victoria. In the longer term the council may devolve management and operation of Keilor Park to a management committee of park users. Regardless of the management model our involvement with the use, operation and enhancement of facilities at the park will require consistent, prolonged effort and possibly considerable expense.

The next 50 years looks interesting......
